

STUDENT ONE SCHOLARSHIPS

TERMS & CONDITIONS

Student One is delighted to offer both the *Australian Assistance Scholarship* and the *SMART Scholarship* to successful applicants. For both scholarships, the following terms and conditions apply:

1) APPLICATION CONSIDERATIONS

- Students are welcome to apply for both scholarships if you consider yourself eligible, but you can only receive one.
- Student One will endeavour to acknowledge all scholarship applications within 2 business days of receiving an application.
- We have a number of places available in both scholarships, and we encourage all interested students to apply. If you are interested in either scholarship, we recommend that you submit your application as early as possible to avoid disappointment.
- Scholarships are awarded at the absolute discretion of Student One.
- Scholarships are only available to Students commencing a new booking with Student One after 1 September 2020.
- Scholarships cannot be combined with any special offers with the exception of free stay vouchers or the refer a friend incentive.
- Students can apply for Scholarships prior to signing, receiving, or accepting an offer from a University or VET provider. Student One will require confirmation of enrolment from the place of study for any scholarship award to be active.
- Applicants must be truthful in their scholarship applications, and willing to further discuss their applications with Student One. Student One reserves the right to ask for documentation to support any scholarship application, if required.

2) RESIDENTIAL AGREEMENT

- Recipients of an Australian Assistance Scholarship must commit to a lease at any Student One residence in any room type and for a duration of between 40 and 52 weeks.
- Recipients of a SMART Scholarship must commit to a lease at any Student One residence in any room type with a duration of 52 weeks.
- Recipients of a SMART Scholarship must be willing to discuss their contribution to the Student One community. Failure to engage with Student One on this matter may result in the cancellation of any scholarship contributions.
- In the rare instance that a scholarship recipient must terminate their Residential Agreement, the recipient will not receive any further weekly scholarship payments from Student One after the agreed-upon termination date.
- Scholarship recipients must immediately notify Student One if they are no longer enrolled as a full-time student.
- All scholarship awardees are expected to abide by all terms and conditions of their Residential Agreement at Student One.
- Scholarships are only available to Students commencing a new booking with Student One after 1 September 2020.

3) FINANCIAL

- Scholarship contributions by Student One are not transferrable to other residents, nor can they be redeemed as cash or as any other form of credit.
- Scholarship contributions by Student One will be processed on a weekly basis. Scholarship recipients cannot request for scholarship contributions to be paid in advance as a larger sum.
- Scholarship contributions by Student One do not affect the Rental Bond amount paid as a requirement of your Residential Agreement
